



YMCA Texas Youth and Government 2018-2019 HIGH SCHOOL PAYMENT AGREEMENT FORM

YMCA Youth and Government allows middle school and high school students to experience the excitement of our state government in action. Students meet regularly as a club during the fall semester. Each club consists of participating students and an adult sponsor (usually a teacher) and is guided by YMCA staff and volunteers. Students choose to participate in one of four areas: legislative, judicial, media, or state affairs forum. Area clubs begin meeting during the fall school semester. In November, clubs compete at District Conference, and the top individuals and teams advance to the State Conference in January.

PARTICIPATION FEE: \$330

Conference fees include: Conference competition and night time activities, conference gift, banquet meal and awards ceremony, lunch and transportation from hotel to conference locations. *Cost listed is four to a room fee.

Additional fees will be due if there are less than four people per room. Additional fee of \$125 due for three to a room. Additional fee of \$310 due for two to a room.

Please note, if your child is not chosen to advance to the **YG State Conference**, any amount paid towards the state conference will be fully refunded without penalty charges.

PAYMENT AGREEMENTS and CANCELLATION GUIDELINES

CANCELLATION FEE:

District Conference: A \$25 cancellation fee will be applied if the cancellation notice for the District Conference is received on October 26, 2018. No refunds or credits will be given for cancellations received after October 26, 2018.

State Conference: If selected to attend the YG State Conference, a \$25 cancellation fee will be applied if the cancellation notice is received on December 14, 2018. No refunds or credits will be applied for cancellations received after December 14, 2018. (Please note, if your child is not selected to attend the YG State Conference, all payments made towards the \$330 State Conference fee will be fully refunded without any penalty charges.)
