THESE PROGRAMS OFFER FACILITIES AND EQUIPMENT IN THE FIELD OF HEALTH ENHANCEMENT, PERSONAL FITNESS EVALUATIONS, AND CLASSES THAT PROMOTE HEALTHY LIFE STYLES THROUGH REGULAR EXERCISE. IN 2010, THE YMCA OF AUSTIN PROVIDED 63,936 PEOPLE WITH OVER \$1.4M AWARDED FINANCIAL ASSISTANCE TO OVERCOME ECONOMIC BARRIERS FOR PARTICIPATION. YMCA HEALTH AND WELLNESS INCLUDES: PEOPLE OF ALL AGES AND LEVELS OF PHYSICAL FITNESS CAN FIND A HEALTH AND FITNESS PROGRAM AT THE YMCA TO MEET THEIR NEEDS, INCLUDING AEROBICS, CYCLING, STRENGTH TRAINING, PERSONAL TRAINING, GYMNASTICS, AND MARTIAL ARTS. THESE ENRICHMENT PROGRAMS EMPLOY CHILD CARE STAFF TRAINED IN IMPLEMENTING CURRICULA TO ASSIST CHILDREN IN DEVELOPING MORAL AND ETHICAL BEHAVIOR, SELF-ESTEEM, AND LEADERSHIP. AFTERSCHOOL LICENSED CHILD CARE, CAMPS AND YEAR-ROUND AFTERSCHOOL CARE AT LEARNING CENTERS (LOW-INCOME HOUSING) ARE THE PRIMARY PROGRAMS.
